## CANCELLATION AND REFUND POLICY

Cancellations must be made in writing to CYOA YACHT CHARTERS St. Thomas office. Upon receipt of written notice of cancellation, refunds (if any) will be made as follows:

- Cancellations received 91 or more days prior to the start date receive a full refund, less \$300 cancellation fee plus 10% of any amount charged to a credit card.
- Cancellations received 90 days or less receive NO REFUND
- Refunds will be made in the same manner as payment was received.
- A change of dates or boat after the contract is issued is considered a cancellation.
